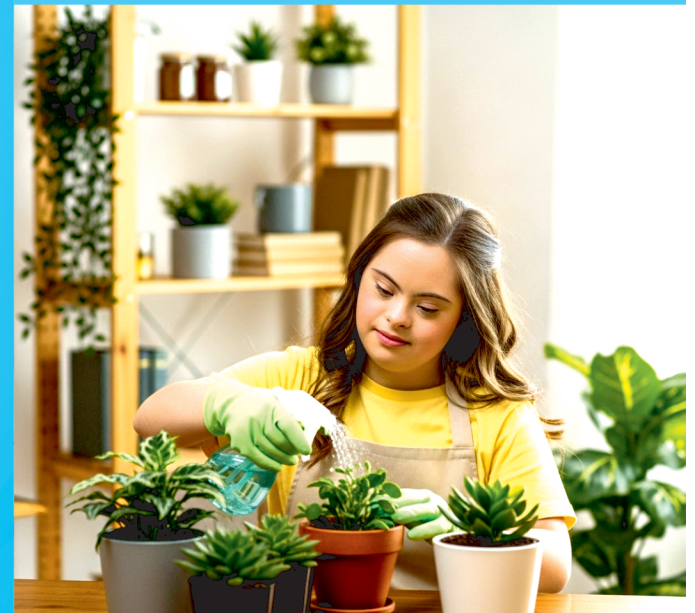

Considering CILA services for your Loved one? Here is what you need to know

1. What is a CILA?

A Community Integrated Living Arrangement (CILA) is a supportive home in the community for adults with intellectual or developmental disabilities.

Residents receive 24/7 care, supervision, and skill-building support so they can live with dignity, independence, and stability.

2. Who Qualifies for a CILA?

- Adults (18+) who have:
- An intellectual or developmental disability
- A PUNS selection or state funding approval
- A need for daily support with living skills, health management, or community engagement

3. Who Needs a CILA?

A CILA is ideal for adults with intellectual or developmental disabilities who need help with daily living skills, medication management, personal safety, or community participation. Individuals who benefit from a structured, supportive home — but do not require nursing-home-level care — are the ones who typically need a CILA.

It's designed for people who want to live in a safe home where they can grow, gain independence, and be part of the community.

4. How Do I Get Placed Into a CILA?

Families begin by:

1. Contacting the Illinois Independent Service Coordination (ISC) agency in their area www.dhs.state.il.us/page.aspx?module=12
2. Completing eligibility steps, assessments, and PUNS enrollment
3. Selecting a CILA provider of their choice- we would be honored to be that choice.
4. Working with the ISC and the chosen provider (NHRH) to complete admission paperwork and plan the move-in process
